





**Gentlemen:**

Transmitted herewith are the Certificates to the Increase of Capital Stock & Amended Articles of Incorporation of the above-named corporation.

Please be informed, also, that the approval of your application/petition is subject to the conditions set forth in the guidelines covering corporations shares of stock as paid-up capital which was adopted by the Commission on November 15, 1994, as follows:

a) That where the payment is made in the form of land, the corresponding shares of stock to be issued thereon shall be held in escrow by the Commission and shall be released only upon the presentation of the proof of the transfer or the certified true copy of title thereto, in the name of the transferee-corporation, is submitted to this Commission within ninety (90) days from the date of approval of the application extendible for justifiable reasons;

b) That where the payment made consists of property other than land, the corresponding shares of stock to be issued thereon shall be held in escrow by the Commission and shall be released only after proof of the transfer of the registration thereon in the name of the transferee-corporation is submitted to the Commission, within thirty (30) days from the date of approval of the application extendible for justifiable reasons;

c) That the non-submission of the documents as required above, within the prescribed period, after due notice and hearing, shall be sufficient ground for the revocation of the related application approved by the Commission or for the institution of appropriate action as the Commission may deem fit under the circumstances.
